Asset Valuation

Assets are estimated based on the last price known to the customary bank information sources. If no price or value is available from customary bank information sources, estimates may be used.

Securities priced at another frequency are valued at their last known price, based on prices and values taken from the customary bank information sources.

Special cases of Hedge Funds: The Bank becomes aware of the net asset value (NAV) at irregular intervals, depending on the fund. The actual NAV calculation date is listed below the specified value. Special cases of currency futures operations: gains and losses correspond to the difference between the agreed-upon exchange rate and the current exchange rate, estimated online with the yield curve. Exchange rates are updated at least once a day.
